

The objective of this agreement is to ensure the harmonious development of Taekwondo in the Lac St. Louis region by respecting the association's members and maintaining healthy and positive relationships between all Dojangs affiliated with the "Fédération Québécoise de Takwondo" (FQT) on the whole territory of Lac St. Louis

Fédération Québécoise de Taekwondo (FQT) Regulations and Criteria for Eligibility

As stipulated in Article 26 of the Regulation 1, I agree:

- To respect the regulations of the FQT.
- To respect the rules of the Sports Safety Board (Régie de la sécurité dans les sports).
- To provide a suitable and safe place for the practice and teaching of Taekwondo.
- To ensure that all active members of the Dojang are registered with the FQT.
- To ensure that all active members of the Dojang train mostly at the physical location of the concerned Dojang.
- To pay all membership fees due to the FQT.
- To fulfill any other conditions that may be determined by the FQT on an ongoing basis.

Ethical Conduct

I agree:

- To respect and implement the "**Code of Ethics**" of the FQT and the "**Coach's Code of Conduct**" of the FQT at all time.
- To never harm the reputation of any other Dojang and its members in any manner whatsoever.
- To never harm the reputation of a board member of the LSLRTA in any manner whatsoever.

Code of Conduct in Competitions

I agree:

- To respect and implement the "**Participant Code of Ethics**" of the FQT and the "**official Code of Ethics**" of the FQT.
- To never harm anyone, including athletes, coaches, volunteers, parents, spectators and officials.

Respecting the Authority of the LSLRTA Board of Directors

I agree:

- To respect the regulations of the LSLRTA.
- To obtain a written authorization from its board before organizing any Taekwondo competition, any seminar, workshop or other businesses leaving the framework of the regular activities of the Dojang, in accordance with Article 17 of the Regulation 2.
- To respect the resolutions of the board of directors and committees, and to respect the operations of the LSLRTA.
- To actively and positively participate in activities organized by the LSLRTA.

Contribution to Financial Activities

I agree:

- To contribute to the best of my ability in financing activities organized by LSLRTA (Competitions, demonstrations and other activities promoting Taekwondo organized by the LSLRTA and its members) in accordance with Article 9 of the Regulation 2.
- To maintain a balance between the financial support received from the LSLRTA and my contribution to financing activities.
- Per the rules established by the LSLRTA Board, to plan ahead and communicate my needs for support regarding courses, workshops, or enhancement activities for the Taekwondo athletes under my responsibility in order to facilitate a balanced yearly budget planning.

Disciplinary actions

Any breach of the Code of Conduct by any of the members of the Federation, under the umbrella of the Lac St. Louis Regional Taekwondo Association, must be communicated in writing to its Board of Directors.

The LSLRTA Board of Directors is responsible to evaluate the complaint and apply the measures deemed necessary to its resolution.

In the case of a serious breach, the Board must forward the complaint in writing to the “Fédération Québécoise de Taekwondo”, in accordance with Article 12 of the Regulation 2. The LSLRTA Board of Directors can then recommend sanctions, suspension or even expulsion of the member(s) or Dojang from the Federation.
